



MITUTOYO MAY GIVEAWAY OFFICIAL RULES

| May 01, 2023

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A purchase or payment will not improve your chances of winning. The Giveaway (the "Giveaway") entry period begins at 1:00 PM Eastern Time ("ET") on May 2, 2023 and ends at 1:00 PM ET on May 9, 2023 (the "Entry Period"), when all entries must be received. Eastern Time shall control for all purposes of this Giveaway. Sponsor's clock shall be the official timekeeper for the Giveaway. The Giveaway is governed by these Official Rules and is subject to all applicable federal, state and local laws. Void where prohibited.

- 1. Eligibility. The Giveaway is open only to legal residents of the fifty (50) United States, who are at least eighteen (18) years old or the age of majority (whichever is older) in their legal state of residence at the time of entry. Proof of residency and age may be required prior to award of any prize. Employees of MSC Industrial Direct Co., Inc. ("Sponsor"), and their respective subsidiaries, divisions, affiliates, and advertising or promotional agencies, and the immediate family and household members of such individuals, are not eligible to enter or win. Entries will be deemed to have been submitted by the authorized account holder of the email address associated with the Instagram account from which entry is made at the time of the entry. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider or organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. (approximate retail value of the prize ("ARV") is \$218.00). Any and all federal, state and local taxes on the prize are the sole responsibility of the winner. If prize or any portion thereof is not accepted, is unclaimed or unused by a winner, it will be forfeited and will not be substituted. No transfer, refund, cash redemption, substitution or replacement of prize or any prize component permitted, except that Sponsor reserves the right, in its sole discretion, to substitute a prize of equal or greater value (or cash equivalent). ARV of prize is in U.S. dollars.
